Melbourne Pigeon Society - Conditions of Membership Notes

Ownership and duty of care:

- All pigeons owned by members of the MPS, Inc. must be maintained under sanitary and pleasant conditions, treated humanely at all times and given necessary health care
- Members in residential areas must have due regard to neighbours when allowing their birds to fly from the loft
- Flight time out of the loft should be supervised by the owner.

III treatment of pigeons:

- The MPS defines ill treatment of pigeons as neglect, wounding, mutilating, abusing, tormenting and torturing, wanton or malicious beating and / or causing unnecessary pain or suffering
- Neglect can be described as the pigeon being presented in a soiled & generally disheveled condition and or harboring external parasites, or inadequately healed wounds.
- These acts are unacceptable to the MPS.

Health and loft management:

- MPS members must make the health and welfare of their pigeons a priority.
- Poor health can be described as a pigeon having symptoms such as lethargy, breathing difficulties, nasal and eye discharge, pigeon pox lesions and the like.
- Lofts should be dry, regularly cleaned and the birds provided with adequate food, water, grit to ensure their ongoing good health.
